RELEASE

I have elected to compete in Lebanon Idol 2014 in a preliminary round on the above circled date and time. I acknowledge that I am at least 16 years of age at the time of the competition. If selected as a finalist, I will perform as a soloist accompanied by a musical track that I will provide. I understand that I will be required to attend a sound check for my final performance at a preselected scheduled time. I will be available for coaching for a time to be determined by the coaches of Lebanon Idol.

This contest is designed for amateur singers only; anyone who is already signed to a label or has representation is not eligible to compete. I understand that no compensation will be received for said performances. If selected by a panel of judges as a finalist and/or winner, it will be my sole responsibility to pay any required taxes on the prize package. I understand that all decisions of the sponsors, their appointed representatives, the judges and the organizations involved are final and binding. The sponsors and their agents are not responsible for printing, distribution or program errors, and a contestant’s participation may be terminated at any time, without notice, at their sole discretion. Failure to abide by all contest rules may result in disqualification from contest. I agree to abide by all contest rules, which are subject to change without notice and hereby agree to release, hold harmless, defend and indemnify The Lebanon Valley Mall Company, Prizm Asset Management Company, Boscov’s Department Stores, LLC, Associates of Lebanon, and Lebanon Broadcasting Company as well as their affiliates, subsidiaries, officers, employees, representatives, agents and all others associated with the contest from any and all claims, damage, loss or liability (including reasonable attorney fees and expenses) suffered as a result of or arising from participation in this contest or the use of any prize.
